## YOUR VACATION DETAILS

This promotional voucher includes a seven-day cruise to Alaska for two adults over 21 years of age. The cruise departs from and returns to Seattle, Washington. Select itineraries are subject to availability and will be assigned by The Fulfillment Center (TFC). Interior Category 1 cabins located on the lower decks are used. Double occupancy is required. Cabin bedding may include an upper/lower configuration (bunk beds). Upgrades to higher decks, preferred configurations, ocean view and balcony staterooms can be purchased through your assigned cruise specialist.

## VACATION REDEMPTION INSTRUCTIONS

STEP 1. Register and pay activation deposit:

Within 30 days from issue date, you must fill out, sign and mail in your certificate along with a \$100 Activation Deposit. This will be applied towards your tax deposit later or fully refundable if you decide not to make a reservation. You can pay the activation deposit payable to My Trips with a personal check, cashier's check or money order.

STEP 2. Make your reservation:

After we receive your deposit, we will mail you your reservation letter that you will fill out in its' entirety and sign. You'll need to provide three travel dates at least 60 days away and 30 days apart. The reservation letter will have an expiration date one year from the date we print and mail it to you. Your sailing dates must be before your expiration date and not during weeks with major U.S. holidays including Christmas, New Years, Independence Day, Labor Day, Presidents Day, and Thanksgiving. We recommend you request dates atleast seven months before your expiration date. If you follow these simple rules about making your reservation, we guarantee that one of your three dates will be selected!!!

STEP 3. Confirm your sailing date:

After you request your three sailing dates, we will send you a confirmation letter with one of your selected dates along with a port charges and tax deposit form. The taxes, fees and other charges are approximately \$369 per person (\$738 total) but since we are going to apply your activation deposit to your tax deposit, you only need to pay an additional \$638 with personal check, cashier's check or money order. Just sign the deposit form and mail it back with your payment. Make sure it is postmarked by the deadline!

STEP 4. Talk to your travel rep: After you confirm your sailing date; we will call you to go over all the last minute details. During this call, you can buy an upgrade to an ocean view stateroom on a higher deck if they are available (they are almost always available). During this call you can also cancel your sailing date and receive a full refund of your deposit, or you can trade in the cruise for a Resort Stay in one of over 4,000 resorts located in one of more than 100 countries. After you finalize everything with your travel rep, we will book and pay for your cruise. Once your cruise has been paid for, we will not be able to guarantee you a full refund if you need to cancel. If you do need to cancel, call us anyway because we might be able to give a partial or sometimes even a full refund.

STEP 5. Enjoy your cruise!!!! Your travel package will be mailed at least 14 days prior to your sailing date. Your travel package will include your cruise itinerary. If we do not use your entire tax deposit, we will also include a check for the unused portion in your travel package.



## TERMS AND CONDITIONS

### Exclusions

This voucher does not include government-imposed taxes, port charges, optional (baggage fees, seating fees, and/or entertainment) transfers, non-commissionable fare (NCF), fuel surcharges, cruise line-imposed surcharges or any incidental expenses such as gratuities, phone calls or entertainment. Taxes will not exceed \$369 per person.

### Deposits & Cancellation

This vacation requires a tax deposit to pay the estimated taxes due. Estimated taxes due are \$369 per person. The tax deposit will be used to pay for government imposed taxes, port charges, fuel surcharges and NCFs. The unused portion will be refunded 14 days prior to your trip. You can receive a full refund of the tax deposit prior to TFC purchasing your travel arrangements by calling (702) 703.2510. Once TFC has purchased your travel arrangements, which will be 21 days prior to your sailing date, cancellation fees up to the total amount of taxes may be imposed and the balance of your tax deposit (if any) will be refunded within 30 days of cancellation. If you cancel at any time, this voucher will be deemed void. This voucher is void where prohibited by law and may not be combined with any other discount or special promotion.
